

## RYDE GLADESVILLE CLIMATE CHANGE ACTION GROUP – SEPTEMBER NEWSLETTER

### RYDE LOCAL COUNCIL CANDIDATES - WHERE DO THEY STAND ON CLIMATE ?

Council elections are on Saturday 13<sup>th</sup> September and local councils have an important part to play on climate. In 2007 Ryde Council produced a draft Greenhouse Gas Reduction Action Plan (a requirement under a wider Federal government program). Our submission argued that the targets for emissions reductions were out of date, no funding had been allocated and the strategies were token (eg buy books for the library on climate change/ educate staff to turn out lights). We asked Council to send it back to the drawing board. Council ignored our request as well as the suggestions we had proposed for the draft plan. The City of Sydney Council has just announced it is carbon neutral and is purchasing 100% Greenpower. Ryde Council plans to purchase 10%. Local government can do much more than Ryde has.

Ryde Gladesville CCAG think that those who represent us (and get up to \$20,000 a year each), need to be informed and ready to act now. We asked a series of questions of the 26 out of 64 candidates for whom contact details were available on the Australian Electoral Commission website. We had 6 responses. Their answers are below:

**Councillor Terry Perram Councillor Independent West Ward declined to answer the questions but provided the following response.**

I don't think anybody knows for certain the full extent of what is happening and what is the best way forward or effectiveness of supposed solutions... The real question in my mind is not about whether climate change is occurring, but instead what is the appropriate response. There seems to be a range of options from one extreme of "just let it happen and deal with the consequences" to "go all out to prevent it from happening regardless of the cost or effect on people". I am sure the appropriate response is somewhere between those extremes and will become clearer as more information is known. Meanwhile the role for community leaders and councils is to evaluate additional information as it becomes available and take appropriate steps based on that information to respond in a meaningful way. That might mean encouraging solar water heating among the community, or it might mean other more cost-effective measures. By the way, I have had a solar water heater on my roof for 28 years. As an engineer, I am not one of the people you have to convince about energy efficiency, but I do have to be convinced about the cost-effectiveness of supposed solutions.

### **MEETING WITH JOHN WATKINS – MEMBER FOR RYDE**

RGCCAG were due to meet with Mr Watkins on Friday 5 September to ask questions about how the power sell off would help reduce emissions and to urge him as Deputy Premier to take some leadership on climate change in the state government. We had been attempting to meet with him since July, having met with him last February. At that time we found him to be interested and receptive and we are disappointed not to have the chance to meet with him again.

### **MAKE A SUBMISSION TO FEDERAL GOVERNMENT ON ITS EMISSIONS TRADING PLAN BEFORE WEDNESDAY 10 SEPTEMBER**

We suggest the following points be made:

I urge that strong interim targets for reducing greenhouse pollution also be adopted.

I am very disappointed that Professor Garnaut's recommendation not to compensate coal-fired power generators has been ignored.

Investment in large-scale renewable energy should be a priority, with a strong Mandatory Renewable Energy Target for 2010.

Money raised from the scheme should be used to assist low income Australians to invest in energy efficiency, rather than tax cuts and increased benefits.
